Sub: Scrutinizer's Report on Postal Ballot conducted pursuant to the provisions of Section 108, 110 of Companies Act, 2013 read with the rules framed thereunder for shifting of the registered office of Greenlam Industries Limited ('Company') from the State of Assam to the National Capital Territory ('NCT') of Delhi commenced on Thursday, February 11, 2021 at 10:00 a.m. and ended on Friday, March 12, 2021 at 5:00 p.m.

Dear Sir,

- 1. I, Nitu Poddar, Senior Associate at M/s Vinod Kothari & Company, Practising Company Secretaries, (Membership No. ACS 37398 and C.P No. 15113) have been appointed as the Scrutinizer by the Board of Directors of the Company in terms of the Resolution passed by the Board of Directors in its meeting dated February 02, 2021 for the purpose of scrutinizing the Postal Ballot process through remote e-voting as per the provisions of Section 108, 110 of Companies Act, 2013 ('the Act') read with the rules framed thereunder, the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, Secretarial Standard-2 on General Meetings issued by the Institute of Company Secretaries of India, as amended from time to time, for the purpose of the shifting registered office of the Company from the State of Assam to NCT of Delhi.
- 2. In terms of Section 108, 110 of the Act read with the rules framed thereunder, the Company availed the services of Link Intime India Private Limited ('LIIPL') to provide the remote e-voting facility to the equity shareholders of the Company for the resolution proposed in the Postal Ballot Notice dated February 02, 2021 ('Notice').
- 3. The Company had sent the Notice by email only to the members of the Company, whose names appeared on the Register of members/ list of beneficial owners as received from the Registrar and Transfer Agent and who had registered their email addresses with the Company and/or with the Depositories as on Friday, February 5, 2021 ("Cut-off date").
- 4. In compliance with the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 39/2020 dated December 31, 2020 and other applicable circulars issued by the Ministry of Corporate Affairs ("MCA") and the Securities and Exchange Board of India ("SEBI") (hereinafter collectively referred to as "Circulars"), the Notice was sent only through electronic mode to those Members whose email addresses were registered with the Company/Depositories as on the Cut-off date. The Notice was also available on the Company's website, www.greenlamindustries.com and websites of the Stock Exchanges where the equity shares of the Company are listed i.e. BSE Limited, www.bseindia.com and National Stock Exchange of India Limited, www.nseindia.com and on the website of LIIPL, the agency engaged by the Company for providing the facility of Remote e-voting to the Members of the Company at

In view of the aforesaid Circulars, the voting through the physical Postal Ballot Form was not applicable.

- 5. The members of the Company holding shares as on the Cut-off date were entitled to vote on the resolution as set out in the Notice.
- 6. The management of the Company is responsible to ensure the compliance of the requirements of the Act, rules, circulars and notifications issued by the MCA with respect to the Postal Ballot process. My responsibility as a Scrutinizer is restricted in making the Scrutinizer's Report of the votes cast "IN FAVOUR OF" or "AGAINST" the business set out in the Notice, based on the reports generated from the e-voting system of LIIPL, the authorized agency engaged by the Company.
- 7. The e-voting facility to facilitate the shareholders of the Company as on the Cut-off date, was open from Thursday, February 11, 2021 (10:00 a.m IST) to Friday, March 12, 2021 (5:00 p.m IST) and the e-voting platform was blocked thereafter.
- 8. The votes cast through the e-voting platform were unblocked by me in the presence of Mr. Bunny Sehgal, Practicing Company Secretary, (Membership No. A39598) and Ms. Shaifali Sharma, Company Secretary (Membership No. A60593) who acted as the witnesses, as prescribed in Rule 22 of the Companies (Management and Administration) Rules, 2014. I have scrutinized and reviewed the Postal Ballot results based on the data downloaded from the LIIPL e-voting platform.
- 9. I now submit the Report on the results of the voting on Postal Ballot through remote e-voting in respect of the said special resolution for shifting registered office of the Company from the State of Assam to NCT of Delhi, as under:
